RAYS REPORT WEEK #2: ROAD TRIP!

The Corpus Christi IceRays are once again loading up the bus for a set of road games. Before the team departs, get all caught up on the hockey action from this past week.

LAST WEEK: The Rays began their seven-game road trip with two games in Frisco against the South Division leading Texas Tornado.

In Friday's game, Jimmy Kruger made 27 saves and the Texas Tornado won their 13th game in a row, 3-1, over the Corpus Christi IceRays at the Dr. Pepper Arena on Friday night. Jonathan Sdao scored his third goal of the season and Pheonix Copley made 36 saves in the losing effort.

In Saturday's game, Texas exploded for seven goals and Jake Stafford pitched his second shutout in as many outings as the Tornado defeated the Corpus Christi IceRays, 7-0, at the Dr Pepper Arena on Saturday night. J.D. Howard and Alec Thieda each had two tallies for the Tornado. Marco Wieser made 38 saves in the loss for Corpus Christi.

BEAU LEADS THE LEAGUE:

Through 20 games played, Beau Walker (West Richland, WA) leads the NAHL with 11 power-play assists.

ATTENDANCE IS TOPS IN THE LEAGUE: Corpus Christi leads the entire NAHL with an average attendance of 3,250 fans per game.

Through 10 games (8 at the American Bank Center), over 32 Thousand fans have watched the IceRays at home in their first season in the league.

If you'd like to watch the game with some IceRays fanatics, Vernon's Bar and BBQ will have the games live on their big screen each night. Vernon's is located on the corner of 3rd St. and Buford.

ICERAYS AGREE TO PLAYER AFFILIATION CONSENT WITH TWO PLAYERS

Corpus Christi IceRays General Manager Pat Dunn announced today that the IceRays have agreed to two player affiliation consent agreements with Midget hockey players Seth Blair and Storm Wahlrab. Both are expected in uniform when the team plays in New Mexico on Thursday and Friday. Under the agreement, the IceRays are permitted to have up to six midget level players dress for a total of six

games each without having to add to or subtract from the roster. After a team has used one of their player affiliation consents for more than six games, they are required to make a roster change if they wish to keep the player.

Blair, 17, currently plays for the Omaha Junior Lancers (18U) in the North American Prospects Hockey League (NAPHL). The 6'3, 210 lb. forward can also play defense. In 10 games this season, the Bismarck, North Dakota native has two goals and six assists for eight points. Last season with the Junior Lancers, Blair tallied three goals and five assists for eight points in 20 games played. In the 2010 playoffs, he scored a goal and had an assist for two points in five playoff contests. He led his 2008-09 Century High School (ND) high school hockey team in scoring as a freshman with 15 goals and 23 assists for 34 points before joining the Junior Lancers.

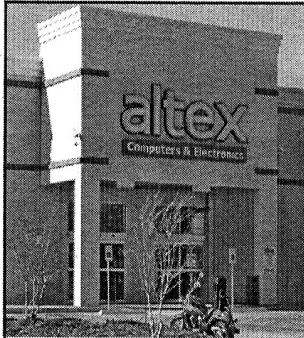
Wahlrab, 16, currently plays for the California Titans (16U) in the North American Prospects Hockey League (NAPHL). The 6'1, 185 lb. defenseman has one goal in 10 games played this season. The Laguna Niguel, CA native will become the youngest member of the IceRays.

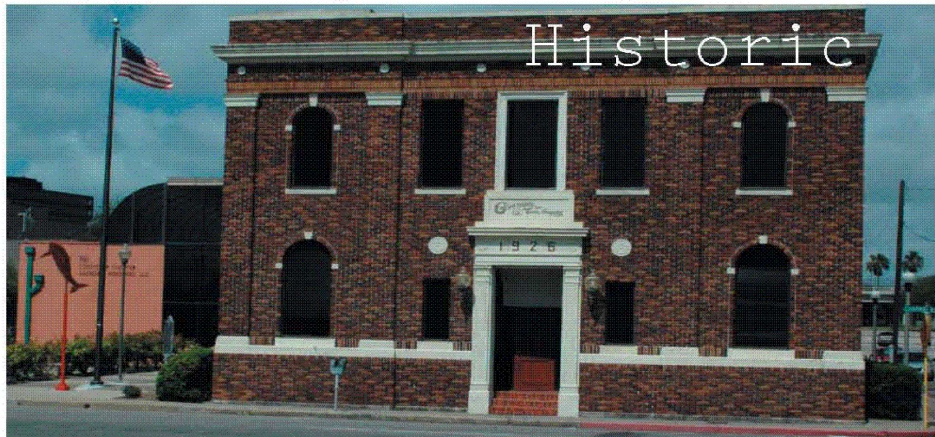

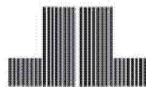
