KEY DEPARTURES PUTS DRAFT FOCUS ON OFFENSE FOR RAYS'

As the Corpus Christi IceRays are set to embark on their fourth season in the North American Hockey League, the departure of key players on the offensive side of the puck puts most of the focus during today's NAHL Draft on offense.

The draft is set for 1PM Central Standard Time and can be listened to for free [HERE](#).

As the season came to a close in the first round of the North American Hockey League's South Division Semifinals, the IceRays knew they were losing their top five point scorers.

"We feel that with the departure of some key players, it's no secret that we are in need of forwards," said head coach Justin Quenneville. "Our focus will be up front and looking to attack the draft from a wide list of players we have narrowed it down too. As always, the team strives to find players with a good skill set, high hockey IQ and above all a good individual."

The key forwards offensively that the IceRays will be losing are players such as Rudy Sulmonte (60pts), Emil Romig (54pts), Perry D'Arrioso (44pts), Mike Economos (35pts), and Beau Walker (32pts). The puts the draft emphasis on offense.

Corpus Christi will pick five times in today's draft. After not picking in the first round due to a trade this past season, the Rays' will have two of those picks in the second round of the draft, with one pick in each of the three rounds.

Fans can listen to the draft live and for free online at www.fasthockey.com. The broadcast today will include live draft pick coverage, analysis of the picks, and interviews.

In addition to listening, fans can follow the IceRays twitter (@goicerays) account for live pick updates.

The number of players each team is able to draft varies on that team's current roster (protected list) minus the number 30 as of midnight of June 3rd. Leading up to midnight of June 3rd, each team's roster is comprised of veteran players and signed tenders only. For example, if a team has 15 veterans rostered and 8 tenders signed as of midnight of June 3rd (23 total), that team is allowed seven (7) draft picks.

The IceRays currently have 25 players either rostered or tendered and will be allowed five picks.

"This is now our 4th Draft Year and its exciting every time," Quenneville finished. "All the visits to rinks across the country, phone calls made, emails replied, and overall work from the scouts, coaches, and hockey staff throughout this year comes down to 5 picks for the organization."

Sen. Cruz Statement on SCOTUS Decision in *Maryland v. King*

U.S. Senator Ted Cruz (R-TX) released the following statement on today's U.S. Supreme Court decision in *Maryland v. King*: Today's unfortunate U.S. Supreme Court ruling in *Maryland v. King*, by a vote of 5-4, expands government power, invades our liberty, and undermines our constitutional rights. The Court held that the police can forcibly take DNA samples from people who have been arrested—but have not been tried or convicted—of a serious offense. So now the government can capture, without a search warrant, the most personal information about an individual, and use it to search vast databases for unrelated offenses.

All 50 States already collect DNA from convicted felons. So this intrusion of liberty will matter only for those not convicted: the innocent and wrongly accused or those for whom there is insufficient evidence to convict.

As Justice Scalia rightly noted in dissent, “As an entirely predictable consequence of today's decision, your DNA can be taken and entered into a national DNA database if you are ever arrested, rightly or wrongly, and for whatever reason.”

All of us should be alarmed by this significant step towards government as Big Brother. The excessive concentration of power in government is always inimical to liberty, and a national database of our DNA cannot be reconciled with the Fourth Amendment.

Accumulating DNA from arrestees—without warrant or probable cause to seize the DNA—is not designed to solve the crime for which the person has (rightly or wrongly) been arrested. Rather, it's to test the DNA against a national database to potentially implicate them in other unsolved crimes. But the Constitution requires particularized suspicion of a specific crime; indeed, the Fourth Amendment was adopted to prohibit the British practice of “general warrants” targeting individuals absent specific evidence of wrongdoing.

Justice Scalia's scathing dissent is right: If we really want a DNA database to solve more crimes, then why not require DNA samples to fly on airplanes, get driver's licenses, or attend public schools?

If the government has good cause for needing the DNA sample—such as trying to match DNA at a crime scene to a particular person where there is other corroborating evidence—then the government can ask a judge for a search warrant. That's what our Framers intended—judicial checks on extensive government power to invade our personal lives.

Law enforcement is a paramount function of government. But we cannot allow that government function to run roughshod over the Bill of Rights. And, as recent events involving the IRS have demonstrated, unchecked government power—and intrusive personal databases maintained on the citizenry—poses real risks to our liberty.
