# Texas Comptroller Helps Feds Crack Down on Fuel Thefts from Military Base

Three men who conspired to steal \$290,000 worth of aviation fuel from Biggs Army Airfield in El Paso have been sentenced to federal prison time after an extensive investigation by federal authorities and the Texas Comptroller's office. A fourth was sentenced to federal probation.

The Comptroller's Criminal Investigation Division (CID) helped gather evidence and worked with investigators from the Department of Defense - Criminal Investigation Service; Internal Revenue Service - Criminal Investigations; U.S. Department of Transportation - Office of the Inspector General; and U.S. Army Criminal Investigation Command - Major Procurement Fraud Unit.

Comptroller Susan Combs has enhanced the role of CID to help federal investigations along with pursuing criminal activity on state taxes.

"Federal investigators can leverage our expertise in catching tax cheats to help with their investigations, and we are glad to help them every chance we can," Combs said. "We have statutory authority to share state tax information that can help federal investigators gain insight into the operations of a business. This ensures that law enforcement has every mechanism possible to prosecute criminals."

Two of the four men involved in the conspiracy, Tomas Quintero and Luis Campos, were employees of a contractor which provided fuel to military and federal civilian aircraft at Biggs Army Airfield. The remaining co-defendants, brothers Fernando J. Baca and Richard Baca, owned gravel truck companies.

From 2007 to 2010, Quintero and Campos conspired to steal aviation fuel from Biggs Army Airfield and sold it to the Bacas who used it for their commercial gravel trucks.

After pleading guilty in March to one count of conspiracy to commit theft and one count of tax evasion, Quintero was sentenced May 31 to 30 months in federal prison. Campos, who pled guilty in March to conspiracy to commit theft, was sentenced to four months in federal prison. Fernando Baca pled guilty to conspiracy to commit theft and IRS-related charges, and received 15 months in prison. Richard Baca was sentenced to 5 years probation for conspiracy to commit theft.

The defendants were also ordered to pay restitution to the Defense Logistics Agency, U.S. Department of Transportation and Internal Revenue Service. Quintero was ordered to pay \$362,134; Campos, \$318,328; Fernando Baca, \$343,832, and Ricardo Baca, \$83,815.

In the last few months Comptroller investigators assisted in several investigations around the state that have resulted in federal indictments, including ten Austin-area residents on federal drug and money laundering charges.

### FIRST STATUE IN U.S. HONORING DRED SCOTT TO BE UNVEILED FRIDAY AT OLD COURTHOUSE IN ST. LOUIS

Statue Honors Leading African-American Figure At Center of One of Key Supreme Court Decisions in U.S. History; Slavery Ruling Contributed to Lincoln Presidential Run, Outbreak of Civil War.

ST. LOUIS, MO//NEWS ADVISORY///A life-sized statue of Dred and Harriet Scott will be unveiled Friday (June 8, 2012) at 3 p.m. CDT in front of the historic Old Courthouse here.

The unveiling of the life-sized statue on June 8th will be the first full statue ever dedicated to Dred Scott and his wife Harriet. As the greatgreat granddaughter of Dred Scott, Mrs. Lynne M. Jackson founded the Dred Scott Heritage Foundation in 2006, and she will participate in the unveiling of the statue as it is gifted to the American people through the National Parks Service. To date, the foundation has raised over \$150,000 towards the statue's \$250,000 dollar price tag.

Others participating in the unveiling ceremony will include: descendants of Dred Scott; St. Louis Mayor Francis Slay, St. Louis Board of Aldermen President Lewis Reed; Utah Attorney General Mark Shurtleff; National Park Service Superintendent Thomas Bradley; and sculptor Harry Weber.

The Old Courthouse in St. Louis is where the Scotts petitioned in 1846 for their freedom from slavery, setting in motion the presidential candidacy of Abraham Lincoln, the U.S. Civil War and three amendments to the U.S. Constitution.

### Cornyn, Hutchison Introduce Bill to Facilitate Critical Updates at U.S. Ports of Entry

U.S. Sens. John Cornyn and Kay Bailey Hutchison, R-Texas, today introduced the *Cross-Border Trade Enhancement Act of 2012*, which would provide new authorities for U.S. Customs and Border Protection to enter into public-private partnerships with either local governments or private sector entities to fund additional staffing at ports of entry. The bill would also require the General Services Administration (GSA) to expedite review of alternative financing arrangements submitted by these partnerships for infrastructure improvements, ensuring that proposals no longer sit on desks in Washington for decades.

"One bright spot for the U.S. economy has been our nation's trade with Mexico, which has grown by leaps and bounds over the past two decades and now supports roughly 6 million U.S. jobs. But in order to continue to foster this important business relationship and create more jobs and growth, action must be taken to update our land ports of entry, which lack the infrastructure and staffing necessary to support such robust levels of trade," Sen. Cornyn said. "This legislation, which results directly from the input of local stakeholders, reflects the fiscal climate in Washington, recognizes that the status quo for our ports of entry is unacceptable, and facilitates positive changes without spending taxpayer dollars.

"I look forward to working with my colleagues, Sen. Hutchison, Congressman Cuellar and others, to advance this legislation in Congress."

"Reducing border wait times and facilitating cross-border trade are two of my top priorities," said Sen. Hutchison. "This legislation will go a long way toward addressing these problems and I look forward to working with my colleagues to find common-sense solutions for our border communities and businesses."
