MEXICO CURES NEWBORNS' CLUB FOOT WITHOUT SURGERY

The first stage of the treatment is successfully fulfilled with the application of four serial plasters.

The physical appearance of the child that has gone through this method resembles the one of the child that has never suffered from this condition.

Two or three newborns out of a 1,500 that are born in the Maternity Hospital of Monterrey, Nuevo León suffer from the club-foot condition. In 60% of the cases, both feet are affected. This Medical Institution cures this condition through the Ponseti Method, which lasts approximately between 4 and 6 weeks and, when applied properly, prevents surgery in 95% of the cases. Doctor Marco Antonio Ascacio Solís, Pediatric Orthopedic Traumatologist of the Maternity Hospital of Nuevo León, explains that the detection of this condition is possible after the 24th week of gestation. This helps the physician in deciding which method is the one that will be applied to cure the child as soon as he is born and, at the same time, persuade the parents to act quickly and opportunely. He added that this is important because if the treatment is applied as soon as the diagnosis is given, the physical, psychological, social and labor handicap resulting of this condition can be avoided, as well as the social rejection caused by not being able to wear regular shoes in maturity.

Additionally, the treatment turns out to be much better if the patient is as young as possible. Since the newborn is very flexible, with only four plasters, the first stage of the treatment is completed successfully. The method is applied in two stages: correction, plasters that are applied in series with gentle manipulation that includes the elongation of the Achilles tendon; and the placement of a ferule with 60 degrees of external rotation. The child must use this ferule every day for 3 or 4 weeks in order to be cured completely. From January to October of this year, this Maternity Hospital has cured 60 patients with a 98% rate of success. Ascacio Solís highlighted the importance of the role that the parents have in checking that the child uses the ferule every day and in not removing it even if they perceive the improvement; otherwise, the foot might go back to its original position. "What is very important and what we are looking for in the long run is that the physical appearance of the child that has gone through this method equals the condition of the child that has never had club foot", he said. The Ponseti International Association has recognized eight specialized centers in seven Mexican cities: Chihuahua, Guadalajara, Mexico City, Villahermosa, Mérida and Oaxaca. In the world, one out of a 1000 newborns have club foot; boys are affected more frequently than girls. Since 2001, the Department of Traumatology and Orthopedics of the Maternity Hospital in Monterrey is qualified to apply this method and is also qualified to train orthopedists all over the country. The Head of the Department is Doctor Jorge Garza Martínez and the orthopedic pediatricians who form part of the team are Santos Serna Reyna, Gabriela Villareal Rivera and Marco Antonio Ascacio.

Sen. Cruz: Families of those killed at Benghazi deserve answers Sends Dear Colleague Letter requesting support for S. Res 225, to create Joint Select Committee to investigate Benghazi attacks

U.S. Senator Ted Cruz (R-Texas) today sent a letter to his Senate colleagues requesting their support for a Joint Select Committee to investigate the September 11, 2012 Benghazi attacks. Sen. Cruz included letters of support from Pat Smith and Michael Ingmire, the mother and uncle of Sean Smith, the Foreign Service Officer killed in the Benghazi attacks.

"We have four Americans killed in the line of duty," Sen. Cruz said. "The State Department's internal Accountability Review Board report has left Congress with fundamental questions unanswered. It is well past time for Congress to do its job and investigate what happened at Benghazi. The families of those killed at Benghazi deserve answers to their questions. We all do. I hope you will consider joining me, and 24 other Senate colleagues, as a co-sponsor of Sen. Res 225."

Sen. Cruz first announced his resolution on September 12, 2013, but his request for unanimous consent to introduce and pass the measure was blocked from consideration by Democrats.

"It is time for the establishment of a Bipartisan Independent Joint Select Committee on Benghazi. Pat Smith, myself, and the other family members of the Benghazi murder victims deserve and demand your attention to this matter," Michael Ingmire wrote. "While there has been some progress via the various committees, some of the most obvious questions I have about what happened in Benghazi have yet to be answered."

"I am absolutely for this resolution," Pat Smith wrote. "I have been asking everyone who would listen to please tell me why my son Sean Smith had to die in a blazing inferno in an outpost in Benghazi, Libya with no security and no hope of the arrival of any help. The State Department has not explained these things to me."
