Reports: Obama to pick Kerry for State

President Obama has decided to nominate Sen. John Kerry (D-Mass.) as the next secretary of State, according to news reports. An unidentified source told CNN that a formal announcement could come as early as next week. ABC News, quoting unidentified sources, said news, including the mass shooting at a school in Newtown, Connecticut, had delayed the announcement. Kerry emerged as the favorite to succeed Secretary of State Hillary Clinton when U.N. Ambassador Susan Rice withdrew her name from consideration. ABC on Friday reported Massachusetts Gov. Deval Patrick is already making plans to fill Kerry's Senate seat and has already had a discussion with Vicki Kennedy, the widow of former Sen. Edward Kennedy (D-Mass.). The developments come after the State Department on Saturday announced that Clinton fainted and suffered a concussion. "While suffering from a stomach virus, Secretary Clinton became dehydrated and fainted, sustaining a concussion," deputy assistant secretary Philippe Reines said in a statement. "She has been recovering at home and will continue to be monitored regularly by her doctors. At their recommendation, she will continue to work from home next week, staying in regular contact with department and other officials. She is looking forward to being back in the office soon." Clinton was due to testify before Congress on Dec. 20 about the investigation into the deaths of four Americans at the U.S. Consulate in Benghazi on Sept. 11. She will not testify as scheduled before the Senate Foreign Relations Committee, said Jodi Seth, a spokeswoman for Kerry, the panel's chairman. The State Department told Kerry of Clinton's concussion on Saturday morning, and, when he heard, Kerry insisted that she not attend the hearing. "Senator Kerry was relieved to hear that the secretary is on the mend, but he insisted that given her condition, she could not and should not appear on Thursday as previously planned, and that the nation's best interests are served by the report and hearings proceeding as scheduled with senior officials appearing in her place," Seth said. Clinton deputies Tom Nides and Bill Burns will testify in her place before Senate and House committees.

Farm Credit Bank of Texas Welcomes New Board Member

Stockholders of the Farm Credit Bank of Texas (FCBT) recently elected Brad C. Bean of Liberty, Miss., to the FCBT Board of Directors. He will serve a three-year term, beginning Jan. 1, 2013. Bean owns a 250-cow dairy operation. His other farming interests include corn, sorghum, grass and timber. Bean currently chairs the Southern AgCredit Board of Directors and is a member of the Farm Credit Bank of Texas Stockholders Advisory Committee and the Tenth District Farm Credit Council. A graduate of Mississippi State University, he is president of the Amite County Farm Bureau, secretary-treasurer of American Dairy Association of Mississippi and a member of the Amite County Cooperative Board of Directors. Bean will fill the director position held by Joe Crawford, who is retiring from the board. The FCBT seven-member board also includes Chairman Jimmy Dodson of Robstown, Texas; Vice Chairman Lester Little of Hallettsville, Texas; Ralph "Buddy" Cortese of Fort Sumner, N.M.; Elizabeth G. "Betty" Flores of Laredo, Texas; Jon "Mike" Garnett of Spearman, Texas; and Dr. William F. Staats of Baton Rouge, La.

The board sets policy for the Farm Credit Bank of Texas, which provides funding and services for the Texas Farm Credit District. With combined assets of \$20.6 billion, the Texas District consists of 17 local lending cooperatives that finance farmers, ranchers, agribusiness, and rural landowners and homeowners in Alabama, Louisiana, Mississippi, New Mexico and Texas.

Senate Passes Cornyn Measure Easing Access to Drinking Water Blocked by Zebra Mussels in Lake Texoma

Today U.S. Senator John Cornyn (R-TX) released the following statement after the Senate passed the North Texas Zebra Mussel Barrier Act of 2012, removing a bureaucratic barrier preventing local water districts from transporting drinking water out of Lake Texoma:

"This bill will allow the Texoma Water Pump to reopen and provide water to the more than 1.5 million people served by the North Texas Municipal Water District and Greater Texoma Utility Authority. It's a commonsense piece of legislation that helps Texans."

In December 2010, the North Texas Municipal Water District (NTMWD) learned that a mistake in identifying the border between Texas and Oklahoma caused the Texoma Water Pump, previously standing solely within Texas, to straddle the state line. Due to the Lacey Act, which prohibits interstate transport of invasive species, like zebra mussels, the pumping of water from Lake Texoma was voluntarily suspended. This bill grants an exemption to the Act to allow the Texoma Water Pump to resume operating, while also removing zebra mussels to prevent contamination. This larger bill containing the North Texas Zebra Mussel Barrier Act will now move to the House of Representatives where companion legislation sponsored by Rep. Ralph Hall (TX-4) passed unanimously earlier this year.
